AGREEMENT

I further agree that I will hold the AHBA, its officers, directors, agents and members harmless and defend them from any and all liability for any injury, claim, damage or loss, of whatever kind or nature, whether to person or property, caused at or near this event, whether directly or indirectly, by me or any dog I have entered in or brought to this event. I agree to indemnify the AHBA, its officers, directors, agents and members for any loss, cost or expense including attorney's fees and costs, to which the AHBA, its officers, directors, agents or members might be subject as a result of any claim, suit, loss or damage caused in any way by any act or negligence on my part or on the part of any dog or dogs I have entered in or brought to this event.
